As all we are aware about the SWACHH BHARAT ABHIYAN Programme announced by Hon' ble Prime Minister Shri Nareendra Modi. - 3) The villagers shall be guided for solid waste management as garbage spreads dirt and disease in the village area.
- 4) Help the villagers to prepare soak pits to minimise spread of house waste water on the road which become the breeding ground for mosquitoes which may spread diseases in the village.
- 5) The villagers shall be motivated to develop kitchen garden behind the house to produce fresh vegetables to improve their health.
- 6) At least one health check up camp can be orgainsed in a year at adopted village.
- 7) One NSS project of 40 hours can be given to the success of 'Swachh Bharat Abhiyan'.
- 8) The 'Swachh Bharat Abhiyan' activities can be successfully completed during NSS Special Camp period.
- 9) Some activities may be organised in Regular NSS activites in adopted village.
- 10) The awareness campaign may be initiated through street plays, film shows, discussions etc.

The NSS Special Camp activity should be organized in adopted area only in the benefit of community.
