




8. **Participation:** Youth to participate in NYPF must be between **18 to 25 years of age as on 01st February 2024**. Deputy Directors and District Youth Officers should coordinate with NSS Regional Directors and Programme Officers for encouraging and motivating their volunteers to participate in District level NYPF in large numbers.
9. **Screening of Participants** – In case of large applications are received at District the concerned DD and DYO may form a committee in coordination with NSS to screen the participants and select minimum 10 participants who may participate in District level NYPF. No budget will be provided for the screening of candidates.
10. **Recognition:** 1st and 2nd ranked/winner youth should be selected from each of the 763 districts. The 1st and 2nd ranked/winner of District Level NYPF would participate in the State Level NYPF. The 1st, 2nd and 3rd ranked/winner will be selected from each State Youth Parliament to participate in National level Youth Parliament. More details in this regard are given in the **enclosed Guidelines**.
11. **Legal:** any dispute w.r.t selection of best youth for participation at District and State level, the decision of NYKS be final and binding.
12. **Wide Circulation:** The above programme details among NYVs, members of Youth Clubs, Education Institutions, Universities and others through mobile phones, social media platforms such as WhatsApp, Facebook, Twitter, E-mail and others should be motivated to participate and circulate among their peers, villagers and other stakeholders.
13. **Media and Publicity for Visibility:**
 - Before and after the event, adequate coverage in both printing and electronic media should be ensured.
 - Extensive use of social media platforms such as Facebook, Twitter, Instagram and WhatsApp shall be ensured.
 - Activities Photographs, videos and press clippings should be sent to NYKS HQ at specialprogramme.nyks@gmail.com and edpnyks2020@gmail.com
14. **Involvement of VVIPs/VIPs:** It should be ensured that the invitation to grace the District level NYPF and State level NYPF is extended to the Hon'ble Cabinet/State Ministers, Hon'ble MPs, Hon'ble MLAs/MLCs. All efforts should be made by concerned State Directors, Deputy Directors and District Youth Officers to involve the eminent dignitaries both at level of District and State NYPF.
15. **Budget** – Budgetary provision for District and State Youth Parliament is placed at Annexure-B and the same will be released by Accounts Section of NYKS HQ shortly.
16. **Reporting:** The detailed guidelines on the reporting will be shared to all field offices shortly. Meanwhile it is required that all District NYKs initiate the process of registration of participants, screening of the participants and Identification of Judges (venue districts).

Subject: Conduct of National Youth Parliament Festival (NYPF) 2024 at District, State and National level- regarding

Sir/Madam,

This has reference to a communication dated 09th February 2024 received from Department of Youth Affairs vide which it has been conveyed that like previous years, **Youth Parliament Festival will be organized at District, State and National level.**

2. The schedule of the Youth Parliament Festival, 2024 at District, State and National level is as per the following timeline:

Level	Dates
District	09 th February to 14 th February 2024
State	19 th February to 24 th February 2024
National	Dates to be intimated later

3. **Guidelines:** A detailed guidelines is enclosed with this letter at **Annexure-A**. This should be shared immediately among Deputy Directors and District Youth Officers and with the direction that contents of guidelines should be read carefully for time bound compliance.
4. **Mode of NYPF** – The District and State Level NYPF will be held in VIRTUAL mode while the National Level Youth Parliament will be conducted in physical mode.
5. **Venue Districts** - For conducting District Level Youth Parliament, 150 specified Nodal Venue Districts have been identified in which 623 District NYKs as well as 150 Non-NYK Districts (total 763 Districts) would participate. A list of specified **150** Venue Districts and participating districts are given in **Annexure-I** of the enclosed Guidelines.
6. **Application Mode** - For all Districts (including Non NYKS) an Event to invite applications on MYBharat has to **be created mandatory on portal**. The physical application for screening should not be accepted in any case. The screened candidates who will be participating in 150 Districts Level Parliaments have to fill the physical form to the District NYK after due verification by NSS PO or DYO's for record keeping purpose.
7. Each of the participant will have to provide self-attested photocopy of the following documents:
- Any Government document viz. domicile certificate, driving license, voter ID, Aadhar Card etc. which verifies that participants belong to a particular district.
 - Passport size photograph
 - Date of Birth Certificate
