Dear Sir / Madam,

In reference to the Ministry of Youth Affairs and Sports/ Directorate of NSS, New Delhi letter P 32-1/2024/NSS/D11/ 1190-1239 dated 09th July 2024 regarding the above mentioned subject.

2. It is to intimate that seven days' residential special camps for NSS Volunteers are being organised by all NSS units as a part of mandatory work. In this regard, Ministry of Youth Affairs and Sports, New Delhi vide its letter mentioned at para 1, has directed that the following may be kept in view while deciding location of the special Camp: -

(a) Location for organisation of special camps in the village/slum should be beyond a minimum **distance of 8 Kms** from the institutions.

(b) Locations with **natural scenic beauty** may be given priority.

It is also suggested that, the location of the camp **should not be beyond the jurisdiction of University of Mumbai.**

3. In this regard, all NSS Units/ Programme Officers are requested to necessary note and do the necessary compliance as per guidelines issued by the Directorate of NSS, Ministry of Youth Affairs and Sports, New Delhi.


**Sub: - Advisory for organisation of seven days residential special camps-Reg.**
